

## vivo Ignite: Technology and Innovation Initiatives

### Terms and Conditions

1. These Terms and Conditions (“**T&C**”), as amended from time to time, are the complete and exclusive statements of understanding between vivo Mobile India Pvt. Ltd. (**‘vivo’**) and the Participant/Users who shall enroll, (through Parent/Legal Guardian/School) to participate in the program named vivo Ignite- Technology and Innovation initiative (hereinafter referred to as “vivo Ignite”/ “Program”). These T&Cs supersedes all other prior understanding, whether oral or written. All representation or other communications between vivo & the Participant amounts to acceptance of these terms and conditions.
2. vivo is organizing a competition for the students of Grades 8 to 12. The User/Participants may enroll directly through the website [www.vivoignite.com/](http://www.vivoignite.com/) . While Stage 1 and Stage 2 level of the Program will be an online process for the Participants. Upon been selected as finalist, the selected Participants need to be accompanied by their Parents/Legal Guardian for the final event.
3. **Age of the Participant:** A Participant must be within 18 years of age in order to be eligible for competing in the vivo Ignite. vivo reserves the right to disqualify Participants for any misrepresentation, concealment, or otherwise.
4. **Program Duration:** The 3<sup>rd</sup> edition of vivo Ignite: Technology and Innovation Initiatives shall commence from 23<sup>rd</sup> December’ 2024 – 15<sup>th</sup> June’ 2025 (*both dates included*).
5. vivo shall provide an online platform for enrolling into the vivo Ignite to the Users/Participants. All registration shall be in accordance with the terms and conditions herein, as may be amended from time to time and/or any other communication as shared by vivo from time to time.
5. By enrolling in the vivo Ignite and/or participating in the vivo Ignite, the Participant unconditionally and irrevocably accepts and agrees to be bound by all these terms and conditions as stated herein. This vivo Ignite is subject to the laws of India and is neither offered, or applicable outside of India.
6. vivo shall not be responsible for any Participant enrolling and/or entering the vivo Ignite unlawfully or otherwise, in breach of any applicable laws and any such consequence shall be the sole responsibility of the Participant and/or his/her Parents/Legal guardian.

7. vivo reserves the right, in its sole and absolute discretion, to terminate or disqualify any Participant's enrolment/participation into the vivo Ignite and/or claim/reclaim the reward at any time if it is the opinion of vivo that there has been a breach of any of the Terms or any law by such Participant (whether discovered during or after the end of the program).
8. All the contents and material of the vivo Ignite is an Intellectual Property of vivo and the User/Participant or any stakeholder involved in implementation/execution or otherwise shall have no right over the same.
9. Any commercial use of the content of the vivo Ignite is strictly prohibited and shall be punishable under applicable laws.
10. The Registration Process is as follows:
  - The Registration shall open from 23<sup>rd</sup> December' 2024 until 10<sup>th</sup> February' 2025.
  - User shall visit [www.vivoignite.com](http://www.vivoignite.com) and click the register/login button.
  - User shall fill in details as required for creation of account. The Parent/Legal Guardian/School may support in the registration process for other prospective Participants as well, other than User.
  - User will sign up with personal details, such as Name, Email ID, Contact Number, School Details or any other details, as may be required.
  - If a Parent wishes to register more than one user, the Parent needs to use an alternate email ID for every subsequent user registration.
  - Access to the vivo Ignite through the Account of the Participant shall be granted for a period of 06 (six) months from the date of successful registration. Participant Dashboard: After registration, the Participants will be taken to their respective dashboards where they can find all the various details regarding their program.
  - For group registration in vivo ignite, the Parent/(s) hereby agrees and acknowledges to take consent from all other participant's Parent and/or legal guardian before registering the names of all users.

11. vivo Ignite will unfold in three stages.

Stage 1: Participants will submit their posters and a brief write-up (150–300 words) about their project. They will also select whether their final submission will be in the form of an

individual entry or a group (min 2 or max 3 members) entry. The deadline of submission of entries is 17<sup>th</sup> February' 2025.

Stage 2: Top 200 (two hundred) shortlisted ideas will submit a video explaining on their prototype. Participants will also upload a PDB (Project Display Board). The deadline of submission of entries is 20<sup>th</sup> April'2025.

Stage 3: The shortlisted students of top 10 (ten) ideas will carry their projects to the physical event for display and final presentation and selection process. The shortlisted students of top 10 (ten) ideas shall be intimated with the details of venue and other necessary information in relation to the event via email communication.

12. The Shortlisting, Selection of the Participants and Mentoring of selected Participants will be done by vivo's CSR implementing partner along with third Party private Partners. The outcome or the results of the vivo Ignite shall be final, and binding upon the participants and the Winners. All such participants undertake not to challenge the same at any point in time.
13. The shortlisted students of top 10 (ten) ideas acknowledge and agree to enter into separate agreement with vivo during the final stages of the Program in order to authenticate and substantiate the utilization of Scholarship fund for academic purposes.
14. Details of the reward to be awarded to the Winners of vivo Ignite:
  - All the Participants who submit their posters and write-ups will be awarded Online Participation Certificates.
  - All the 200 (Two Hundred) participants who make it to the Stage 2 will be awarded a certificate and exciting goodies ("**Goodies**").
15. Scholarships worth Upto INR 35,00,000 (Rupees Thirty-Five Lacs Only) will be awarded to the shortlisted students of top 10 (ten) ideas ("**Winners**").
16. The Participants and their concerned Parent/Legal Guardian/School acknowledge and agree that the Participant and/or the concerned Parent/Legal Guardian/School shall be solely responsible in undertaking informed decision in regard to conceptualizing the idea/concept and the associated operational implementation required for the Project at

all stages of Program. The Participants and/or the respective Parent/Legal Guardian/School affirm and agree that vivo only acts as a facilitator and will be facilitating support to the Participants only through mentoring activities. In event of any damage, injury, losses incurred while making, presenting or implementing the Project at any or all stages of the Program, vivo shall not be held responsible or liable in any manner whatsoever.

17. The Participants and their Parent/Legal Guardian affirm and acknowledge that the ideas/presentations submitted in the program is original work and have not been copied, plagiarized and/or poached of any individual/ third party. In event any such violation is found, vivo reserves the right to disqualify such Participant from the Program at its sole discretion.
18. The Participants and their Parent/Legal Guardian affirm to undertake full onus and responsibility in event of any such violation and shall indemnify vivo against any claims made in this regard and/or any cost incurred by vivo in relation to this matter.
19. vivo reserves the sole right and discretion to amend/replace the reward(s) of equivalent value to the Winners and such winners shall not have any objection in this regard.
20. In event of implication of any applicable taxes in relation to Scholarship or goodies received under this Program, the Participants and their Parent/Legal Guardian acknowledges and agree to comply with the same.
21. Any traveling and/or lodging cost associated with Participation in the vivo Ignite Grand Finale shall be solely borne by vivo as per below:
  - Individual Entry: Travel and stay arrangements for the student and 1 (One) Parent/guardian/teacher will be made by Team vivo Ignite.
  - Group Entry: Travel and stay arrangements for the group (min 2 or max 3 members) and only 1 (One) Parent/guardian/teacher will be made by Team vivo Ignite.
22. Children of employees of vivo including its subsidiaries, affiliates, and/or any of its affiliated partner/vendors/contractors/agent shall not be eligible to participate in this Program. This restriction ensures to stimulate fairness, transparency, and equal opportunity for all external participants. Any entries found to be in violation of this clause will be disqualified immediately without prior notice.

23. The rewards for the vivo Ignite will be given to the Winners as set out in the Terms and Conditions. The Winners must accept his/her reward in that form only. Rewards are non-negotiable, non-transferable, non-refundable and not exchangeable for cash, credit or kind, either in part or in full except at the sole and absolute discretion of vivo.
24. vivo reserves the right, in its sole and absolute discretion, to deal with any unclaimed rewards in any manner.
25. vivo shall not be liable in any way for any failure or breach by any party in connection with the vivo Ignite, and accepts no responsibility for any loss suffered by a Participant arising from the vivo Ignite.
26. By participating in the vivo Ignite, the Parent/Legal Guardian on behalf of Participant agrees and allows with their free consent: (a) the usage of their photos, name, quotes, personal details and/or likeness, without any compensation, for vivo promotional and marketing purposes in relation this Program; and (b) to use their answers to the questions, without any compensation, for vivo's promotional and marketing purposes, either directly or through any third party in relation this Program.
27. The Parent/Legal Guardian and the Participant acknowledge that vivo may reach out to Participants upon attaining age of majority in relation to the Program either directly or through any third party.
28. The Participant(s) shall ensure that the content is not obscene, vulgar, defaming, denigrating women or children, hurting religious sentiments, depicting violence. In the event of any violation to the aforementioned, the Participant(s) shall immediately be disqualified from taking part in the Contest or any further rounds of participation and shall solely remain liable and responsible for any action (criminal/civil) arising therefrom.
29. Any attempt by a Participant to deliberately damage or undermine the legitimate operation of the vivo Ignite and tarnish the image of vivo ignite or Vivo as a brand is a violation of Criminal and Civil Laws and should such an attempt be made, vivo reserves its right to seek damages from any such Participant along with the criminal liability to the fullest extent as permitted by law.
30. During the Program duration, any written, audio and visual content created by vivo during the vivo Ignite shall be the sole proprietary, interest, right and title of vivo.
31. vivo, and/or its subsidiaries, offices and representatives shall not be liable to any person or entity for any direct, indirect, incidental, special, punitive or consequential damages, including loss of profits, incurred by the Winner(s) or any third party, whether in connection with this vivo Ignite, or for breach of any warranty or in tort.
32. The Participant/User agrees to indemnify vivo, its agents, employees, representatives, associates, affiliates, parent and subsidiary companies against any and all claims, losses,

costs, damages, liabilities and expenses arising out of the Participant's breach of any of the T&C or arising out of or in connection with their entries to the Program.

33. The Participant, by entering the vivo Ignite, expressly releases vivo from any claim, action or demand arising out of or in connection with the vivo Ignite or their reward, if any.
34. vivo shall not assume any responsibility for incorrect or inaccurate capture of any Participant's information. This will include but not be limited to technical malfunctions, human or technical errors, seeding or printing errors, lost or delayed or garbled data or transmissions, omissions, interruptions, deletions, defects or failures of any telephone or computer line or network, computer equipment, software or any combination thereof.
35. The laws of India shall govern these T&Cs. The courts of Delhi will have exclusive jurisdiction in case of any dispute arising under the Terms and Conditions herein.
36. Any provision of the T&C that is prohibited or unenforceable in any jurisdiction shall be ineffective as to that jurisdiction to the extent of that prohibition or unenforceability. That does not affect the validity or enforceability of that provision in any other jurisdiction nor invalidate the remaining provisions of the T&C.
37. Failure by vivo to enforce any of these Terms and Conditions in any instance(s) shall not give rise to any claim by any person.
38. This vivo Ignite is being created as a Corporate Social Responsibility activity for vivo and all goodwill, copyright, moral rights or other intellectual property rights associated thereto shall vest exclusively with vivo.
39. The participation and Winning is subject to the Winner complying with all T&C and/or formalities as required by vivo. Any failure on the part of the Participant to comply with any specified term, condition and/or formality shall render the Participant liable for disqualification at the sole discretion of vivo.
40. User Communication: Participants hereby explicitly consent to receive communication from vivo or its representatives by email, telephone, WhatsApp or SMS for the purposes of providing alerts and information about the Program. In event Participant chooses DND mode, vivo shall cease to send alerts and information about the Program.
41. User Content: The information, photo, image, chat communication, text, software, data, music, sound, graphics, messages, videos or other materials transmitted, uploaded, posted, emailed or otherwise made available to vivo ("**User Content**"), are entirely the User's/Participant's responsibility and vivo will not be held responsible, in any manner whatsoever, in connection to the User Content. The User/Participant agrees not to encourage or assist or engage others as well as himself/herself in transmitting, hosting, displaying, uploading, modifying, publishing transmitting, updating or sharing any information that belongs to another person and to which the user does not have any right.

vivo shall in no way be held responsible for examining or evaluating User Content, nor does it assume any responsibility or liability for the User Content. vivo does not endorse or control the User Content transmitted or posted on the site by the User and therefore, accuracy, integrity or quality of User Content is not guaranteed by vivo. Under no circumstances will vivo be liable in any way for any User Content, including without limitation, for any errors or omissions in any User Content, or for any loss or damage of any kind incurred by him/her as a result of the use of any User Content transmitted, uploaded, posted, e-mailed or otherwise made available via the site. The User hereby waives all rights to any claims against vivo for any alleged or actual infringements of any proprietary rights, rights of privacy and publicity, moral rights, and rights of attribution in connection with User Content.

42. Account: The User/Participant will be responsible for maintaining the confidentiality of his/her account, password, and restricting access to his/her computer, and he/she hereby accepts responsibility for all activities that occur under his/her account and password. The Participant acknowledges that the information he/she provides does not infringe any rights of any third party. If a User is accessing, browsing and using the site on someone else's behalf; he/she represents that he/she has the authority to bind that person to all the terms and conditions herein. In the event that the person refuses to be bound as the principal to the Terms and Conditions, he/she agrees to accept liability for any harm caused by any wrongful use of the site resulting from such access or use of the site. If a User knows or has reasons to believe that the security of his/her account has been breached, he/she should contact vivo immediately. If vivo finds a breach or suspects a breach of the security of a User's/Participant's account, vivo may require the User to change the password or suspend the account without any liability to vivo. vivo reserves the right to refuse service and/or terminate accounts without prior notice if these Terms and Conditions are violated or if vivo decides, in vivo's sole discretion. 43. vivo reserves the right, in its sole and absolute discretion, to amend or vary any of these Terms & Conditions at any time without prior notice or intimation and It consider as deemed acceptance by the user.
44. By enrolling in the vivo Ignite and/or participating in the vivo Ignite, the Participant hereby acknowledges and agrees to abide by the Terms and Conditions, Privacy Policy, and other policies as may be amended from time to time on the site
